- 3. Cambridge Trust Quarterly Investment Report & Investment Discussion: Below are some key highlights from LD's review. A copy of the full report is available at Town Hall.
  - a. LD reviewed both fixed income and equity market trends at a global level, as well as in relation to the Town of Amherst's portfolio.
  - b. LD reviewed various indicators and trends relative to recession forecasting across global markets.
  - c. The performance of both the Town of Amherst Capital Reserve Fund and the Common Trust Fund were reviewed in detail.
  - d. Current cash flows were reviewed for the Town of Amherst Common Trust Fund. LD and LT presented various investment options. The Trustees approved an investment strategy appropriate for the anticipated cash flows for the fund.
